# THREE COUNTY CONTINUUM OF CARE POINT IN TIME COUNT JANUARY 2023 

## ON JANUARY 25TH, 2023 THERE WERE AT LEAST 661 PEOPLE EXPERIENCING HOMELESSNESS IN BERKSHIRE, FRANKLIN, \& HAMPSHIRE COUNTIES

The Point in Time Count is an attempt to determine how many people are experiencing homelessness in Berkshire, Franklin, \& Hampshire Counties during a single night in January.
This report presents a look at who is experiencing homelessness in our region as well as comparisons to previous point in time counts going back to January of 2020. All data gathered was either from surveys presented to people experiencing homelessness or collected by local shelter providers in the local Homeless Management Information System (HMIS) and general demographic comparisons were obtained through the 2017-2021 ACS 5year estimates available on data.census.gov.

The point in time count wouldn't be possible without the efforts of street outreach providers, shelter providers, volunteers, and more social service agencies committed to the efforts to end homelessness in Western Massachusetts and the willingness of our unhoused community members to take part. ## About the Count

The federal department of Housing and Urban Development (HUD) requires that Continuums of Care (CoCs) undertake a Point in Time (PIT) Count within the last 10 days of January. HUD specifies the ways we can conduct the count-there are some areas we have choice and others we do not. We
don't always agree with the requirements but it helps us to have consistency from year to year and we do our best to find workarounds that will benefit our community. Some of the ways we do that are by conducting 'unofficial' counts and additional counts at other times of year- in 2023 we are preparing for a Summer Count on June 14th.

HUD requires that we only include people experiencing homelessness under HUD's definition- this includes someone who is literally outside or in an encampment, sleeping in a vehicle, or who is in an emergency shelter. We know that people experience homelessness in more situations, so our
'unofficial' count tries to determine how many people are experiencing homelessness in any way and is only shared with the community, although we aren't allowed to accept self reports so the number of people we identify who aren't in shelters or literally outside is much smaller than reality. Some other limitations of the count are that we are in a region with rural areas, sometimes large, and it's difficult to get a sense of how many people are experiencing homelessness outside of the larger cities and towns.

Lastly, I want to emphasize that the number of people experiencing homelessness we identify in the count is not comprehensive of everyone experiencing homelessness in Berkshire, Franklin, and Hampshire counties. There are people who do not want to be located or who are experiencing what we sometimes call 'invisible homelessness' which means they are experiencing homelessness but not in an immediately apparent way, such as doubled up with family or friends or living in hotel or motels.

Since the end of pandemic era policies--which kept people housed and expanded faster access to housing--we have seen an increase in the number of people experiencing homelessness in each county. This includes an increase in both family and individual homelessness, veteran homelessness, and young adult homelessness.

## County Breakdown



Of those experiencing homelessness in the Three County region, 622 were experiencing homelessness per the HUD definition of being in shelter or literally outside and 39 people were experiencing homelessness not under HUD's definition. This includes people who were couch surfing or doubled up, living at a hotel or motel paid for with their own funds, and people in institutional facilities who otherwise do not have a place to stay.

As you can see in the graph and table above, individuals who are Black or African American or Hispanic or Latino/a/x make up a greater proportion of all individuals experiencing homelessness than the general population. For example, Black or African American individuals account for $\sim 13 \%$ of all individuals experiencing homelessness, but only $2.3 \%$ of the total population in Berkshire, Franklin, and Hampshire counties combined and Hispanic or Latina/o/x individuals make up over $13 \%$ of the population experiencing homelessness compared to $5.4 \%$ of the general population.

These disparities should primarily be attributed to structural racism and inequality in addition to the individual factors which contribute towards anyone experiencing homelessness. Non-Hispanic White individuals make up a smaller proportion of the population experiencing homelessness than they do the general population because they benefit from the inequalities which harm everyone who is not White and Non-Hispanic. This leads to a greater chance that they will have assistance or supports to avoid entering homelessness.

We generally do not capture the number of families experiencing unsheltered homelessness in the point in time count because families that are living in cars, motels, or with friends and family fear speaking to social workers about their situation because it may put them at risk of losing their children to DCF; often referred to as invisible homelessness.

As seen below, Hispanic or Latino/a/x persons are drastically overrepresented among families experiencing homelessness. 41\% of everyone in families experiencing homelessness identifies as Hispanic or Latino/a/x, compared to $5.4 \%$ of the general population. Black or African American persons are also very overrepresented compared to the general population, making up over $18 \%$ of everyone in families experiencing homelessness compared to $2.3 \%$ of the general population.

Even though men are overrepresented in the population experiencing homelessness, women are overrepresented in the population of families with children experiencing homelessness. This includes parents and children and leads us to believe that most families experiencing homelessness are either a couple with children or a single mother with children, although these are not the only two scenarios we see.

We also see racial and ethnic disparities among subpopulations such as Young Adults as represented in this graph and the accompanying chart below. Particularly, Young Adults who identify as Hispanic or Latino/a/x are overrepresented when compared to the general population of 18-24-year-olds in Berkshire, Franklin, and Hampshire Counties- making up over 20\% of unaccompanied young adults and $60 \%$ of young adult parents. Young adults of more than one race are also overrepresented among those experiencing homelessness, almost $15 \%$ of unaccompanied young adults and $20 \%$ of parenting young adults compared to almost $6 \%$ of the general population.

In addition to racial and ethnic disparities, although the graph above does not contain the gender breakdown for 18-24 year olds, young adult parents are 80\% female compared to almost 40\% of unaccompanied young adults, and the general population (age aside) is close to 50/50 male and female. We can also see that Unaccompanied/Individual young adults have a greater representation of those who identify as Non-Binary (8.8\%) or Transgender (2.9\%) than the total population experiencing homelessness (0.70\%) or parenting young adults (0\%).

## Veterans

After a sharp decline in veterans experiencing homelessness when the COVID19 pandemic began and VA programs expanded eligibility, we are now seeing an increase in veteran homelessness, although not up to 2020 levels. Veteran service providers have worked hard to house large numbers of veterans in past years and the increase is likely at least partially due to the end of some COVID19 expansions or programs.

## 'Unofficial' Count

For the 'official' Point in Time count report which we submit to HUD every year, we can only include people who are experiencing homelessness under HUD's definition. The 'official' Point in Time count excludes anyone who is couch surfing or staying with family/friends temporarily, anyone living in a hotel or motel they are paying for out of pocket, and anyone temporarily in an institution of any kind without a place to stay otherwise.

We know that people are experiencing homelessness even if they are not in one of the specific situations HUD considers to be an experience of homelessness, so we try to get a sense of how many people are experiencing homelessness in the ways listed above through what we call the 'unofficial' count. Unless specified, the numbers and charts in the sections above do not include everyone who did not meet the HUD definition of homelessness on the night of the count, January 25th 2023.

## On January 25th, 2023 there were at least 39

 people experiencing homelessness across Berkshire, Franklin, and Hampshire Counties either through couch surfing, living in a hotel or motel, or who were temporarily in an institution without a place to go when they leave. This is in addition to the 622 people experiencing homelessness through staying in an emergency shelter or transitional housing program or who are sleeping rough, in an encampment, on the street, or in a vehicle.
